



TEXT MESSAGE POLICY

As a part of being a Premier Acceptance (“Premier”) customer and by providing your cell phone number on an application submitted to Premier or given to Premier by other means, you have provided us with consent to send you text messages in conjunction with your account. If we modify this Text Message Policy, we will notify you by sending you a text message with a link to the new policy. We may terminate our text message program at any time.
